Results are located on the first five tabs of your spreadsheet, pertaining each to Harlingen, Waco, Austin, Laredo, and San Antonio.

A few of these targeted A#'s relate to USCs and we have flagged them in red. Also, a few of the names/DOBs of the targets relate to USCs and are also flagged in red. The name/DOB match is of course a less-confident indicator, but is also probably worth a double-check of the alienage of the targets.

We identified two in-ICE-custody targets. They are flagged in green.

Yellow is an indicator of fugitive status and orange is an indicator of current LPR status (though these two indicators probably are not immediately useful for you).

If we have a NCATC-developed last known address, we provide it in the spreadsheet.

I hope this is helpful.
